1. On 23 May 2018, the vendors, the purchaser and the Company (the “Parties”) entered into a sale and purchase agreement (“Sale and Purchase Agreement”), subject to the terms and conditions of which the vendors agreed to sell, and the purchaser agreed to acquire the sale shares, representing 55% equity interest in 北京金准韋特智能科技有限公司, at the consideration of HK\$96,000,000, which shall be satisfied (i) as to HK\$3,000,000 in cash; and (ii) as to HK\$93,000,000 by the issue of the exchangeable note by the purchaser which can be exchanged into the convertible bonds issued by the Company. The Parties procured fulfilment of conditions precedent in the Sale and Purchase Agreement before 31 July 2018. While on 5 September 2018, the Parties entered into a supplemental agreement to the Sale and Purchase Agreement to extend the abovementioned deadline to 31 October 2018.

Upon exercise of the conversion rights attached to the convertible bonds, the convertible bonds can be converted into conversion shares of the Company which will be allotted and issued under a specific mandate.

The Company will convene a general meeting to seek approval from the shareholders of the Company for the grant of a specific mandate prior to conversion of the convertible bonds.
