As stated in the Announcement, the Company expects to despatch the Circular containing, among other things, details of (i) the proposed Share Consolidation; (ii) a notice convening the SGM to Shareholders on or before Tuesday, 9 May 2017.

In light of the revision of the expected timetable, it is expected that the despatch of the Circular will be postponed to a date falling on or before Wednesday, 24 May 2017.
